PAYMENT

All fees and bond cheques must be received by July 2, 2026 by either one of the following options:

- Post-dated cheque dated for August 1, 2026
- Bank Draft
- Online Payment

Please make Cheques payable to: Bonnyville Minor Hockey Association (BMHA)

*NSF cheques immediately VOID the player's registration and the registration process will need to be completed again with a \$35.00 NSF fee and late registration charges being applied if applicable.

PLAYER REGISTRATION POLICY

- Deadline to register is July 2, 2026 for returning players to avoid a late fee.
- Two bond cheques are required for each registered player;
 - One undated bond cheque for the amount of \$300
 - One undated bond cheque for the amount of \$350
- Any players residing outside BMHA boundaries are subject to BMHA approval and appropriate provincial association approval.
- U7 players must be 4 years old by December 31 of the current registration year.
- In the event that team rosters are too full upon the July 2nd registration deadline, players will need to try out for the team. If they do not make the team, a full refund will be issued and players will be released to other communities.
- BMHA reserves the right to accept your registration based on availability within the age-appropriate division.
- **Late fee does not apply to first time players in BMHA and imports**

Any required releases, concessions, or other documentation must be submitted to BMHA before the player's first ice-time, and is the responsibility of the player. BMHA will, to the best of their ability, try and ensure that players are aware of all required documentation at the time of registration. However, it is ultimately the parent's responsibility to read registration policies and complete any required documents.

FUNDRAISING

If you do not participate in BMHA required fundraising, your bond cheque(s) will be cashed. Fundraising Opt Out Fee

You may choose not to participate in fundraising and pay a higher registration fee. Please add \$650 to your player registration payment if you choose this option.

Please make cheques payable to: Bonnyville & District Minor Hockey Association. *NSF cheques immediately VOID the player's registration and the registration process will need to be completed again with a \$35.00 NSF fee and late registration charges being applied if applicable.

Open to players born on or after January 1st, 2009 and before December 31st, 2017.

Open to players NOT registered to an association team.
